Program consists of 200, 300 or 500 hours of course work. The course dates are continuously run throughout the year.

200hrs = 7 weekends + 44 observation classes

300hrs = 10 weekends + 64 observation classes

500hrs = 17 weekend + 108 observation classes

In addition to these group training sessions each student will be required to practice and complete a written observation form signed by the teacher of the class they participated in.

Cost

Registration Fee: \$100 (subtract the \$100 from total tuition price once submitted)

Tuition: **RYT200** = \$2,950 includes 1 year unlimited yoga

300 = \$4,499 includes 18 months unlimited yoga

Cancellations and Refunds

Once the course has begun no refunds are given for cancellation of enrollment. Tuition must be received at least seven(7) days prior to the beginning of the training. If tuition has been paid and a student needs to cancel, the school must receive a letter in writing notifying this need at least five(5) days prior to the start date to receive a refund. A full refund will be issued minus the \$100 registration fee. In the event of an emergency during the training, a student will be allowed the opportunity to "make up" the missed dates at a future training session. This training is demanding and intensive so it is imperative that once a commitment has been made to begin training the student follows through with this decision.

Agreement is Binding

This agreement will be binding only when it has been fully completed, signed and dated by the student and an authorized representative of the school prior to the time the instruction begins.

Changes in the Agreement

Any changes in the agreement will not be binding on either the student or the school unless changes are acknowledged in writing by an authorized representative of the school and by the student or the student’s parent or guardian if he/she is a minor.

Effective Date of Acceptance

I certify that I have read and understand the cancellation and refund policy; I have received a copy of the school brochure; and I am entitled to an exact copy of this Enrollment Agreement and any other papers I sign. I hereby agree to abide by the conditions set forth herein.

Discontinued Programs

If the school discontinues instruction in any program after the students enter training, including circumstances where the school changes its location, students must be notified in writing of such events and are entitled to a pro-rata refund of all tuition and fees paid unless comparable training is arranged for by the school and agreed upon, in writing, by the student. A written request for such a refund must be made within 90 days from the date the program was discontinued or relocated and the refund must be paid within 30 days after receipt of such a request.

Termination by the School

A student who fails to maintain satisfactory progress, violates safety regulations, interferes with other students’ work, is disruptive, obscene, under the influence of alcohol or drugs, violates the intentions of the yamas and niyamas, or does not make timely tuition payments, is subject to immediate termination.

Cancellation of Classes

The school reserves the right to cancel a starting class if the number of students enrolling is insufficient. Such a cancellation will be considered a rejection by the school and will entitle the student to a full refund of all money paid.

Notice to Buyer

Do not sign this agreement before you read it or if it contains any blank spaces. This is a legal document. All pages of this agreement are binding. Read both sides of all pages before signing. You are entitled to an exact copy, of this agreement and any other papers you may sign and are required to sign a statement acknowledging receipt of those.

Cancellation of Contract

If you have not started training, you may cancel this contract by submitting written notice of such cancellation to the school at its address shown on the contract, which notice shall be submitted not later than midnight of the fifth business day (excluding Sundays and holidays) following your signing this contract or the written notice may be personally or otherwise delivered to the school within that time. In the event of dispute over timely notice, the burden to prove service rests on the sender.
